

TEMPORARY CLOSURE VARIOUS ROADS (ST BRIAVELS PARISH) FOREST OF DEAN DISTRICT

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close the roads as described in the schedule below.

The reason for the closure is to allow for the safe installation of Gigaclear fibre.

The roads are expected to be closed on a rolling programme commencing on the 30th July 2021 where the presence of approved signage will indicate whether the closures are in force. Further advance warnings of dates/times will be displayed on site prior to the closures taking effect. This order can permit the closures of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by 30th October 2022.
