

TEMPORARY CLOSURE AND RESTRICTION OF VARIOUS ROADS (VARIOUS PARISHES) FOREST OF DEAN DISTRICT

Gloucestershire County Council, as traffic authority, has <u>made</u> an Order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the lengths of road as detailed in the Schedule below.

It is anticipated all works will be completed by **16:30hrs on 31st March 2026**.
